

ELECTION TO PARTICIPATE

Under this program, Travelzoo has offered to make payments to persons who establish that they were shareholders of Travelzoo.com Corporation, but failed to submit, within the time required, their requests to receive shares of Travelzoo Inc. in the merger of Travelzoo.com Corporation into Travelzoo Inc. which became effective in 2002. The time period for submitting such requests expired under the terms of the merger agreement in April of 2004. The payment will be based on the average of the closing prices of the Travelzoo Inc. common stock on the NASDAQ Stock Market for the 10 trading days preceding receipt by Travelzoo of satisfactory evidence of eligibility.

IMPORTANT: You may participate in this program <u>only</u> if you have not received shares in Travelzoo Inc. and if you can <u>establish</u> that you are a former stockholder of Travelzoo.com Corporation by providing

- the e-mail address which you registered with Travelzoo.com Corporation; or
- your serial numbers which were issued to you when you registered.

To establish your eligibility, you will need to complete, sign and submit this form as indicated, and also provide us with a copy of a government issued photo id.

1. *Changes in Program Terms*. The terms of this program are subject to change by Travelzoo at any time.

2. Delivery of Election to Participate. To participate in this program, a properly completed and signed original of this Election to Participate, together with a legible photocopy of your driver license, passport or other acceptable photo identification which matches the name you have provided in this Election to Participate and the name which Travelzoo.com Corporation had on file for you, must be received by Travelzoo Inc. while the program is still in effect. 3. Payment to be Made. If Travelzoo Inc. determines that you have satisfactorily established your eligibility to receive payment under the program, the payment to you will be equal to the average closing price of the common stock of Travelzoo Inc. on the NASDAQ Stock Market for the ten trading days immediately preceding the date on which your eligibility has been so established, multiplied by the number of shares of common stock that you would have been entitled to receive under the terms of the merger agreement between Travelzoo.com Corporation and Travelzoo Inc. if you had submitted your request for shares in accordance with the terms of the merger agreement. Such number of shares shall be conclusively determined by the records of Travelzoo Inc.

4. *Timing of Payment.* The payment to you will be made by a check mailed to the address you have provided within ten business days following the expiration of 20 days after your Election to Participate has been received and your eligibility to participate has been satisfactorily established. During that 20-day period you may revoke your decision to participate in the program by delivering a Notice of Withdrawal as referred to below.

5. *Election Not to Participate.* If you do not wish to participate in this program, you do not need to do anything.

6. *Withdrawal.* To validly withdraw this Election to Participate, you must properly submit a Notice of Withdrawal in the form which has been provided to you together with this form of Election to Participate, in accordance with the instructions in the Notice of Withdrawal. Such Notice of Withdrawal must be received prior to the end of the 20-day period referred to in 4. above.
